The Road Safety Program, initially established by the UN as a field-level intervention, offers standardised and high-quality road safety training aimed at reducing road crash risks—the leading cause of casualties in the aid sector.

Their assessment ensures the relevance, appropriate level, and adherence to the highest standards of trainer competence and course quality.

ALIGNED WITH UN STANDARDS

Our Road Safety Training Program aligns with Annex XVI of the latest version of the UN Security Management Operations Manual (SMOM), meeting its requirements. Additionally, TGS fulfills the SMOM definition of professional trainers, delivering the UNSSC-developed program and gaining RoSPA assurance.

MAIN OUTPUTS

LEVEL 2 ASDT

Our ASDT course, developed specifically to address the high risk of road crashes faced in challenging driving contexts, focuses on standardised, behavior-based training for sustained impact. The comprehensive training includes advanced driving theory, practical handling, and in-car coaching in both urban and rural settings, ensuring the development and maintenance of safe driving behavior.

ASDT QUALIFICATION STANDARD

To qualify, drivers must meet five performance objectives, equipping them with the proficiency to safely, efficiently, and comfortably transport passengers and goods in light vehicles or armoured vehicles:

- Safe Driver: Analysing driving behavior, mitigating personal risk factors, and continuously improving driving style and habits.
- Safe Journey: Conducting roadworthiness checks, preparing for safe journeys, and effectively managing journey risks.
- Safe Progress: Applying the system of vehicle control in diverse road, traffic, and weather conditions to ensure safe, efficient, and comfortable progress.
- Safe Control: Precisely placing the vehicle, maintaining grip, stability, and using the correct position, speed, and gear.
- Urban and Rural Driving: Integrating all competencies to navigate road and traffic conditions with skill, confidence, and responsibility.

LEVEL 3 QDT

Our QDT course emerged as a sustainable and cost-effective solution to mitigate road crash risks. It equips participants with the skills, knowledge, and attitudes necessary to instruct, coach, and assess advanced safe driver training.

Using proven behavior-based, client-centered techniques adapted to the aid sector context, the QDT course utilises the Roadcraft handbook, originally designed for safer emergency services drivers.

QDT QUALIFICATION STANDARD

Qualified Driver Trainers (QDTs) possess the following capabilities:

- Level 2 Advanced Safe Driver qualification at a 'fully proficient' level.
- Methods of Instruction: Delivering ASDT knowledge and skills lessons effectively in both classroom and vehicle settings.
- Methods of Coaching: Demonstrating effective in-car and on-road coaching techniques.
- Methods of Assessment: Consistently assessing driver proficiency in an effective and comprehensive manner.
- Methods of Delivery: Efficiently planning, administering, and delivering ASDT sessions.

CAPACITY DEVELOPMENT AND ONGOING SUPPORT

Building internal capacity to deliver standardised and effective driver training plays a pivotal role in reducing road crash risks. Our program provides the flexibility to train personnel as needed, fostering mentorship and encouraging safe driving habits on an ongoing basis.

QDTs are qualified for three years, benefit from ongoing technical support, certification services, and access to ASDT online training modules. Various re-certification options are available, eliminating the need for repeating the entire course.

ALIGNED WITH UN & INTERNATIONAL STANDARDS

UN guidance on driver training (UNSMS SMOM Ch XX) recognises QDT-qualified trainers as certified to deliver training to UN staff members.
